**SUBJECT:** Public Records Request – Post-*Chatrie* ALPR Compliance & Audit Logs

To the Custodian of Records:

Pursuant to Article I, Section 24 of the Florida Constitution, and Chapter 119, Florida Statutes, I request the following records in electronic format.

This request concerns OCSO's administrative and operational compliance with the Fourth Amendment standards established in *Chatrie v. United States*, 608 U.S. \_\_\_ (June 29, 2026), regarding comprehensive digital location histories.

Please produce records sufficient to show the following:

- 1. Policy & Guidance Adaptation** Records sufficient to show any internal guidance, instructions, or criteria used to interpret or apply the *Chatrie* ruling to OCSO's use of Automated License Plate Readers (ALPRs) or Flock Safety systems. This includes memos, updated General Orders, or roll-call directives issued from June 29, 2026, to the present.
- 2. Vendor Coordination** Records sufficient to show communications between any agency employee and Flock Safety (or any @flocksafety.com address) regarding the *Chatrie* decision, location history retention, or geofence queries, from June 29, 2026, to the present.
- 3. Execution Logs (Query Metadata)** Records sufficient to show how OCSO personnel have evaluated and executed ALPR database queries post-*Chatrie*. Please provide the System Audit Logs or User Query Logs from June 29, 2026, to the present. Pursuant to Fla. Stat. § 316.0777, OCSO must redact all exempt license plate numbers, vehicle owner names, and target images. Produce only the segregable metadata:

- Timestamp

- Officer/User ID
- Stated Search Justification / Reason Code
- Any associated judicial warrant docket number

**4. Warrant Compliance Ledger** Records sufficient to show any internal tracking ledger, database, or report documenting probable cause warrants sought or obtained specifically for ALPR or historical location data queries after June 29, 2026.

**5. Definitional Clarification** If any search justification codes or reason fields utilized in Item 3 are undefined within OCSO's written policy, please produce records sufficient to show the administrative data dictionary or schema defining those terms.

***Mandatory Constraint:** This request seeks only administrative, policy, and compliance metadata. It explicitly does not request the identities of investigative targets or active criminal intelligence. If no records exist for any category above, please confirm that no such records were created or maintained. If any portion is denied, you are required to cite the specific exemption and provide all reasonably segregable portions.*
